#### 1 Document flow

- 1.1 National Risk Assessment developed according to version 3-0 of *FSC-PRO-60-002* supersedes National Risk Assessment developed according to the version 2-0 of *FSC-PRO-60-002*, subject to 1.2.
- 1.2 'Low risk' designation in National Risk Assessments approved according to the version 2-0 of *FSC-PRO-60-002* remains valid until 31 December 2017.
- NOTE: National Risk Assessments approved according to version 2-0 of *FSC-PRO-60-002* are listed in Annex A of this procedure addendum.
- 1.3 Copies of National and Regional Risk Assessments are available from FSC on request and are published on the Global Forest Registry (http://www.globalforestregistry.org).
- 1.4 The risk designation included in approved Risk Assessments is transferred to the Global Forest Registry (<u>http://www.globalforestregistry.org</u>) upon approval.
